DDSN is preparing for the release of its new web-based system for the Public Reporting of Provider Data. Family members, advocates, and providers have all participated in the development of this new reporting system. This valuable input helped determine which data, how much data, and which features of the report would be most useful for individuals who will use the reporting system. The web-based system has an interactive design that allows the user to click on various tabs for additional information. DDSN is now prepared to launch the new reporting system. However, before it goes live, DDSN is offering families, advocates, and providers a special demonstration to preview the system.

Two demonstration sessions are planned: one for family members and advocates and a second for providers. The reason for the two separate demonstrations is to better focus the demonstration on the various aspects of the system mindful of the different stakeholder perspectives.
