I. SCOPE OF SOLICITATION

ACQUIRE SERVICES (JAN 2006)

The purpose of this solicitation is to acquire services complying with the enclosed description and/or specifications and conditions. [01-1010-1]

Services are to include one annual fire alarm system inspection and testing for each of the buildings listed on the drawings. Campus head end equipment and software is also to be maintained. Inspection and testing shall comply with the Scope of Work/Specifications of this solicitation. Award will be made to the lowest bidder for the total of years 1 through 5.

MAXIMUM CONTRACT PERIOD - ESTIMATED (Jan 2006)

Start date: **August 1st, 2015** End date: **July 31st, 2020** Dates provided are estimates only. Any resulting contract will begin on the date specified in the notice of award. See clause entitled "Term of Contract - Effective Date/Initial Contract Period". [01-1040-1]

The initial term of this contract will be one year and include four one-year options to renew.

UNIT PRICES REQUIRED (JANUARY 2006):

Unit prices shall be shown for each year of service.

SUBSTITUTIONS: Requests for substitution must be submitted in writing to the procurement officer at least six (6) days prior to the bid date. Proof of equality of substitution is the responsibility of the proposer. The procurement officer's decision to approve or disapprove of the requested substitutions shall be final.

The contractor shall have in his/her possession all tools and equipment required to effect repairs, cleaning, and inspection of the fire alarm systems including, but not limited to: extension cords, vacuum cleaner, test meters, canned smoke, heat gun or hair dryer suitable for testing heat detectors and other cleaning supplies required for complete preventative maintenance of the entire system.

Contractor shall notify the fire alarm monitoring service of the cleaning, inspection and testing of the system prior to performing the service and after service is completed.

Contractor shall verify that the equipment installed matches the documents and/or drawings provided. If not, update documents and/or drawings as required (Mark-up all documents noting differences between documents and actual installation.)

2. INSPECTION, TESTING, CLEANING & FIELD REPAIRS

- A. Inspection
 1. All inspections shall comply with NFPA 72.

2. Contractor shall visually inspect all fire alarm equipment and note any deficiencies in wiring, damage to devices, missing devices, and potential code related irregularities. Note: Fire alarm systems should be inspected to the appropriate edition of the code in effect at time of installation.

B. Testing

1. Check FAC/Dialer battery(s) with battery analyzer. If battery(s) are defective, replace with new. If battery(s) are over (4) years old, replace with new. Replacement battery(s) should be fresh with minimum capacity of 8AH with replacement date sticker.
2. Activate all pull stations.
3. Activate a pull-station and verify that the HVAC air handlers shut-down all operational capabilities of the air distribution system in accordance with the listing of and labeling of the equipment used in the system.
4. Remove AC power (turn breaker off) from FAC and activate a pull-station and verify that all horns/strobes are operational and that all magnetic smoke doors are released.
5. Activate all smoke detectors with one shot of can smoke per head. Perform sensitivity tests when due.
6. Activate all rate-of-rise fixed temperature (135° F) heat detectors with hair dryer.
7. Activate all resettable attic fixed temperature (190° F) heat detectors with heat gun. Temperature of heat gun not to exceed 200° F. Do not over heat.
8. During testing of devices, verify that all remote LED lamps (for bedrooms, and attic heat detectors) illuminate as required.
9. Sprinkler Checks:
 - a. Turn PIV handle toward closed position (2 ½ full turns). Verify supervisory trouble signal is reported to FAC.
 - b. Turn riser shut-off valve(s) toward close position (one full turn). Verify supervisory trouble signal is reported to FAC.
 - c. For dry sprinkler systems, short low pressure switch contacts and verify supervisory trouble signal is reported to FAC.
 - d. Short contacts on flow switch and verify ALARM signal is reported to FAC. Do not flow water.
10. Verify during testing that all signals (trouble and alarms) are reported to FAC/FAA with correct zones/addresses.
11. Signal Verifications:
 - a. Verify that the DACT/Dialer has a live dedicated and a live capture telephone line to the monitoring station.
 - b. Check GENERAL TROUBLE to monitoring station by removing battery lead on FAC/DACT battery.

- c. If separate FAC and dialer, check general trouble from FAC and general trouble from dialer. d.

Check ALARM to monitoring station by activating a pull station.

- e. Record sent and received times for ALARM and GENERAL TROUBLE. This can be done via telephone or other methods. Travel time for a signal should not exceed 90 seconds.
12. All Carbon Monoxide detectors that are interconnected to the fire alarm system shall be tested according to NFPA 720 and the products manufacturer's specifications.
 13. After completion of inspection, return all equipment back to normal (sprinkler valves to be locked) and notify monitoring station to put system back on ALARM.
 14. Head End Equipment: Software on campus head end equipment shall be maintained.
 15. Sensitivity Testing of Smoke Detectors:
 - a. For addressable systems – Provide print out from FAC showing sensitivity of each head. To be performed at each annual inspection.
 - b. For non-addressable systems – Provide calibrated smoke sensitivity test for each head at first inspection and thereafter every (2) years.
 - c. Note: If head fails sensitivity test after cleaning, replace with new.

C. Cleaning

1. Wipe down outside of all equipment using electronic wipe cloth and vacuum out inside of equipment, to include smoke/heat detectors, FAC, FAA, dialer, pull stations, horn/strobes, and sprinkler switches.

D. Field Repairs

1. Contractor shall maintain sufficient spare parts for the systems being tested on any given day so that repairs may be accomplished during the inspection/testing visit. Prior to effecting repairs, contractor shall notify the appropriate Midlands Center Maintenance Director who can issue a Purchase Order for any work costing \$300.00 (Three Hundred Dollars) or less. For any amount over this, the Midlands Center shall notify Statewide Project Manager at DDSN Engineering and Planning.
2. Special Note to Contractor: This contract includes minor repairs such as replacement of smoke/heat detectors and miscellaneous electrical repairs. Callbacks will be compensated by cost of material plus 25%. Labor and travel charges shall be excluded for return visits unless approved by Statewide Project Manager at DDSN Engineering and Planning in advance. It is the intent of this contract to effect repairs at the initial visit so the system is in working condition after the service. **This agency may seek competition for such services outside of the inspection, testing, and maintenance specified in this solicitation, at its discretion or as may be required.**

3. DOCUMENTATION

A report identifying the work performed (i.e. inspections and list of needed repairs), date, time initiated and time completed, printed name and signature of the technician performing work and the printed name and signature of the staff personnel accepting the system certification. This report shall be given to Midlands Center Maintenance Office, and the Contractor shall also maintain a copy of the reports.

This report shall also include the smoke detector sensitivity testing and calibration results.

All four (4) categories of work must be completed within 12 months from the last DHEC Fire Alarm Inspection. Equipment

is to be inspected, serviced and maintained as listed. Bidder is responsible for acquiring all necessary manuals needed to perform contract. Location of equipment is enclosed. Note that each line item gives location by general area where equipment is located. Personnel performing service on equipment should be trained and know codes pertaining to the equipment area. **A sample of documentation shall be submitted with bid.**

(1) Contractor shall purchase from and maintain in a company or companies lawfully authorized to do business in South Carolina such insurance as will protect the contractor from the types of claims set forth below which may arise out of or result from the contractor's operations under the contract and for which the contractor may be legally liable, whether such operations be by the contractor or by a subcontractor or by anyone directly or indirectly employed by any of them, or by anyone for whose acts any of them may be liable: (a) claims under workers' compensation, disability benefit and other similar employee benefit acts which are applicable to the work to be performed; (b) claims for damages because of bodily injury, occupational sickness or disease, or death of the contractor's employees; (c) claims for damages because of bodily injury, sickness or disease, or death of any person other than the contractor's employees; (d) claims for damages insured by usual personal injury liability coverage; (e) claims for damages, other than to the work itself, because of injury to or destruction of tangible property, including loss of use resulting therefrom; (f) claims for damages because of bodily injury, death of a person or property damage arising out of ownership, maintenance or use of a motor vehicle; (g) claims for bodily injury or property damage arising out of completed operations; and (h) claims involving contractual liability insurance applicable to the Contractor's obligations under the provision entitled Indemnification -- Third Party Claims.

(2) Coverage shall be written on an occurrence basis and shall be maintained without interruption from date of commencement of the work until date of final payment. Coverage must include the following on a commercial basis: (i) Premises -- Operations, (ii) Independent Contractor's Protective, (iii) Products and Completed Operations, (iv) Personal and Advertising Injury, (v) Contractual, including specific provision for contractor's obligations under the provision entitled Indemnification --Third Party Claims, (vi) Broad Form Property Damage including Completed Operations, and (vii) Owned, Non-owned and Hired Motor Vehicles.

(3) The insurance required by this paragraph shall be written for not less than the following limits of liability or as required by law, whichever coverage is greater.:

(4) Required Documentation. (a) Prior to commencement of the work, contractor shall provide to the state a signed, original certificate of liability insurance (ACORD 25). The certificate shall identify the types of insurance, state the limits of liability for each type of coverage, include a provision for 30 days notice prior to cancellation, name every applicable using governmental unit (as identified on the cover page) as a Certificate Holder, provide that the general aggregate limit applies per project, and provide that coverage is written on an occurrence basis. (b) Prior to commencement of the work, contractor shall provide to the state a written endorsement to the contractor's general liability insurance policy that (i) names every applicable using governmental unit (as identified on the Cover Page) as an additional insured, (ii) provides that no material alteration, cancellation, non-renewal, or expiration of the coverage contained in such policy shall have effect unless the named governmental unit(s) has been given at least thirty (30) days prior written notice, and (iii) provides that the Contractor's liability insurance policy shall be primary, with any liability insurance of the state as secondary and noncontributory. (5) Contractor shall provide a minimum of thirty (30) days written notice to every applicable using governmental unit of any proposed reduction of coverage limits (on account of revised limits or claims paid under the General Aggregate) or any substitution of insurance carriers.

(6) The state's failure to demand either a certificate of insurance or written endorsement required by this paragraph is not a waiver of contractor's obligations to obtain the required insurance.

CONTRACTOR PERSONNEL (JAN 2006)

The Contractor shall enforce strict discipline and good order among the Contractor's employees and other persons carrying out the Contract. The Contractor shall not permit employment of unfit persons or persons not skilled in tasks assigned to them. [07-7B060-1]

CONTRACTOR'S OBLIGATION -- GENERAL (JAN 2006)

The contractor shall provide and pay for all materials, tools, equipment, labor and professional and non-professional services, and shall perform all other acts and supply all other things necessary, to fully and properly perform and complete the work. The contractor must act as the prime contractor and assume full responsibility for any subcontractor's performance. DEFAULT (JAN 2006)

(a) (1) The State may, subject to paragraphs (c) and (d) of this clause, by written notice of default to the Contractor, terminate this contract in whole or in part if the Contractor fails to:

(i) Deliver the supplies or to perform the services within the time specified in this contract or any extension;

(ii) Make progress, so as to endanger performance of this contract (but see paragraph (a)(2) of this clause); or

(iii) Perform any of the other material provisions of this contract (but see paragraph (a)(2) of this clause).

(2) The State's right to terminate this contract under subdivisions (a)(1)(ii) and (1)(iii) of this clause, may be exercised if the Contractor does not cure such failure within 10 days (or more if authorized in writing by the Procurement Officer) after receipt of the notice from the Procurement Officer specifying the failure.

(b) If the State terminates this contract in whole or in part, it may acquire, under the terms and in the manner the Procurement Officer considers appropriate, supplies or services similar to those terminated, and the Contractor will be liable to the State for any excess costs for those supplies or services. However, the Contractor shall continue the work not terminated.

(c) Except for defaults of subcontractors at any tier, the Contractor shall not be liable for any excess costs if the failure to perform the contract arises from causes beyond the control and without the fault or negligence of the Contractor. Examples of such causes include (1) acts of God or of the public enemy, (2) acts of the State in either its sovereign or contractual capacity, (3) fires, (4) floods, (5) epidemics, (6) quarantine restrictions, (7) strikes, (8) freight embargoes, and (9) unusually severe weather. In each instance the failure to perform must be beyond the control and without the fault or negligence of the Contractor.

(d) If the failure to perform is caused by the default of a subcontractor at any tier, and if the cause of the default is beyond the control of both the Contractor and subcontractor, and without the fault or negligence of either, the Contractor shall not be liable for any excess costs for failure to perform, unless the subcontracted supplies or services were obtainable from other sources in sufficient time for the Contractor to meet the required delivery schedule.

(e) If this contract is terminated for default, the State may require the Contractor to transfer title and deliver to the State, as directed by the Procurement Officer, any (1) completed supplies, and (2) partially completed supplies and materials, parts, tools, dies, jigs, fixtures, plans, drawings, information, and contract rights (collectively referred to as "manufacturing materials" in this clause) that the Contractor has specifically produced or acquired for the terminated portion of this contract. Upon direction of the Procurement Officer, the Contractor shall also protect and preserve property in its possession in which the State has an interest.

(f) The State shall pay contract price for completed supplies delivered and accepted. The Contractor and Procurement Officer shall agree on the amount of payment for manufacturing materials delivered and accepted and for the protection and preservation of the property; if the parties fail to agree, the Procurement Officer shall set an amount subject to the Contractor's rights under the Disputes clause. Failure to agree will be a dispute under the Disputes clause. The State may withhold from these amounts any sum the Procurement Officer determines to be necessary to protect the State against loss because of outstanding liens or claims of former lien holders.

(g) If, after termination, it is determined that the Contractor was not in default, or that the default was excusable, the rights and obligations of the parties shall, if the contract contains a clause providing for termination for convenience of the State, be the same as if the termination had been issued for the convenience of the State. If, in the foregoing circumstances, this contract does not contain a clause providing for termination for convenience of the State, the contract shall be adjusted to compensate for such termination and the contract modified accordingly subject to the contractor's rights under the Disputes clause.

(h) The rights and remedies of the State in this clause are in addition to any other rights and remedies provided by law or under this contract.

TERMINATION FOR CONVENIENCE (JAN 2006)

(1) Termination. The Procurement Officer may terminate this contract in whole or in part, for the convenience of the State. The Procurement Officer shall give written notice of the termination to the contractor specifying the part of the contract terminated and when termination becomes effective.

(2) Contractor's Obligations. The contractor shall incur no further obligations in connection with the terminated work and on the date set in the notice of termination the contractor will stop work to the extent specified. The contractor shall also terminate outstanding orders and subcontracts as they relate to the terminated work. The contractor shall settle the liabilities and claims arising out of the termination of subcontracts and orders connected with the terminated work. The Procurement Officer may direct the contractor to assign the contractor's right, title, and interest under terminated orders or subcontracts to the State. The contractor must still complete the work not terminated by the notice of termination and may incur obligations as are necessary to do so.

(3) Right to Supplies. The Procurement Officer may require the contractor to transfer title and deliver to the State in the manner and to the extent directed by the Procurement Officer: (a) any completed supplies; and (b) such partially completed supplies and materials, parts, tools, dies, jigs, fixtures, plans, drawings, information, and contract rights (hereinafter called "manufacturing material") as the contractor has specifically produced or specially acquired for the performance of the terminated part of this contract. The contractor shall, upon direction of the Procurement Officer, protect and preserve property in the possession of the contractor in which the State has an interest. If the Procurement Officer does not exercise this right, the contractor shall use best efforts to sell such supplies and manufacturing materials in accordance with the standards of Uniform Commercial Code Section 2-706. Utilization of this Section in no way implies that the State has breached the contract by exercise of the Termination for Convenience Clause.

(4) Compensation. (a) The contractor shall submit a termination claim specifying the amounts due because of the termination for convenience together with cost or pricing data required by Section 11-35-1830 bearing on such claim. If the contractor fails to file a termination claim within one year from the effective date of termination, the Procurement Officer may pay the contractor, if at all, an amount set in accordance with Subparagraph (c) of this Paragraph.

(b) The Procurement Officer and the contractor may agree to a settlement and that the settlement does not exceed the total contract price plus settlement costs reduced by payments previously made by the State, the proceeds of any sales of supplies and manufacturing materials under Paragraph (3) of this clause, and the contract price of the work not terminated;

(ii) costs reasonably incurred in performing the terminated portion of the work less amounts paid or to be paid for accepted supplies or services;

(iii) reasonable costs of settling and paying claims arising out of the termination of subcontracts or orders pursuant to Paragraph (2) of this clause. These costs must not include costs paid in accordance with Subparagraph (c)(ii) of this paragraph;

(iv) any other reasonable costs that have resulted from the termination. The total sum to be paid the contractor under this Subparagraph shall not exceed the total contract price plus the reasonable settlement costs of the contractor reduced by the amount of payments otherwise made, the proceeds of any sales of supplies and manufacturing materials under Subparagraph (b) of this Paragraph, and the contract price of work not terminated.

(d) Contractor must demonstrate any costs claimed, agreed to, or established under Subparagraphs (b) and (c) of this Paragraph using its standard record keeping system, provided such system is consistent with any applicable Generally Accepted Accounting Principles.

IMPORTANT TAX NOTICE - NONRESIDENTS ONLY

Withholding Requirements for Payments to Nonresidents: Section 12-8-550 of the South Carolina Code of Laws requires persons hiring or contracting with a nonresident conducting a business or performing personal services of a temporary nature within South Carolina to withhold 2% of each payment made to the nonresident. The withholding requirement does not apply to (1) payments on purchase orders for tangible personal property when the payments are not accompanied by services to be performed in South Carolina, (2) nonresidents who are not conducting business in South Carolina, (3) nonresidents for contracts that do not exceed \$10,000 in a calendar year, or (4) payments to a nonresident who (a) registers with either the S.C. Department of Revenue or the S.C. Secretary of State and (b) submits a Nonresident Taxpayer Registration Affidavit - Income Tax Withholding, Form I-312 to the person letting the contract.

The withholding requirement applies to every governmental entity that uses a contract ("Using Entity"). Nonresidents should submit a separate copy of the Nonresident Taxpayer Registration Affidavit - Income Tax Withholding, Form I-312 to every Using Entity that makes payment to the nonresident pursuant to this solicitation. Once submitted, an affidavit is valid for all contracts between the nonresident and the Using Entity, unless the Using Entity receives notice from the Department of Revenue that the exemption from withholding has been revoked.

Section 12-8-540 requires persons making payment to a nonresident taxpayer of rentals or royalties at a rate of \$1,200.00 or more a year for the use of or for the privilege of using property in South Carolina to withhold 7% of the total of each payment made to a nonresident taxpayer who is not a corporation and 5% if the payment is made to a corporation.
