<p style="text-align: center;">Regional Training 2015: Vulnerable Adult Abuse, Neglect and Exploitation</p> <p>The South Carolina Adult Protection Coordinating Council invites you to attend a free training event in your area. The training will address key issues and concepts associated with allegations of abuse, neglect and exploitation of vulnerable adults in our state.</p> <p>Utilizing actual cases, the focus will be on: 1) assessing an allegation in relation to the provisions of the Omnibus Adult Protection Act; 2) discussing reporting requirements; 3) distinguishing the investigative steps to address the allegation, clarify and understand the role of investigators and mandatory reporters; and 4) formulating a response to the incident that protects the victim, meets the needs of the victim and when appropriate, holds the offender accountable.</p> <p>Discussion topics will also include issues of powers of attorney, competency and capacity, HIPAA, and undue influence.
